This tropical townhouse is positioned at the rear of a small complex of 4 homes. It has a sheltered front verandha with a screen of tropical gardens and twin sets of sliding doors that allow access into a generous light filled living room with sky high roofline drawing the eye to the feature pendant lighting strung over the staircase to the void above. The living areas are all open plan with a free flowing design from the living room to the dining room, kitchen to the outdoors. The kitchen offers wrap-around counters with ample bench space and storage along with a pantry and overhead cupboards as well. There is a walk-in pantry / laundry room with linen press and a WC.

Sliding doors from the dining room lead through to a sheltered rear verandah that overlooks a paved courtyard with towering palms and shaded tropical gardens. Down the side of the home is a second parking bay along with a mounted clothes line.

Upstairs the home has 3 bedrooms all with views over the treetops. The master bedroom has a walk-in robe along with a built-in study desk, balcony access and an ensuite bathroom while bedrooms 2 and 3 each have a built-in robe with corner display shelving. The main bathroom has a bath / shower combo and a separate toilet.

Additionally there is a storage unit off the carport and under the stairs as well – great for the Xmas tree, the bikes and extra bits and bobs.

Only 5 minutes from the heart of the CBD, this property allows you to drop the daily commute in favour of more free time without compromising on space at all. Take an orange scooter through to the city in under 5 minutes or walk up the street to meet friends for a coffee at one of many cafés or restaurants along the strip. The Water Front Precinct is not far away as is Cullen Bay and the Esplanade all basking in the glorious sea breezes and tropical vibes.
